MINUTES

- 1. President Jonn Lau called the meeting to order at 7:00 P.M. Present were Jonn Lau, George Rovder, David Hughes, Ed Fendley, Suzanne Sundburg, Dean Foster, Kate Mattos, Larry Smith, and Craig Deering.
- 2. The Board voted to approve the minutes of the June 25, 2014, Executive Board Meeting.
- 3. Reports From the Officers and Committee Chairs
 - a. President Jonn Lau
 - Site Plan Review Working Group (SPRWG): Jonn Lau reported on highlights of the Arlington County SPRWG Meeting which he attended. His notes are attached.
 - ii. Ballston BID Board Members Jonn Lau, Kate Mattos, Larry Smith, and Suzanne Sundburg met with Ballston BID Executive Director Tina Leone to discuss ways for BCA to become a more active participant in the BID.
 - iii. New Arlington County Police Liaison for BCA, Officer Cesar Ruiz, will be invited to address the General Membership at the September meeting.
 - b. First Vice President Kate Mattos reported on progress of the Bluemont Village taskforce she co-chairs.
 - c. Second Vice President Larry Smith gave no report.
 - d. Treasurer David Van Wagner was absent.
 - e. Secretary George Rovder reported on Presentation by Ballston BID and ForestCity, owner of Ballston Common Mall which he had attended.
 - f. Neighborhood Conservation Advisory Committee (NCAC) Representative Ed Fendley reported that there will likely be a \$12M bond on the ballot this November, and that the BCA project, to improve safety on Wilson Boulevard (see item 2h below), is likely to be funded in the current cycle. This is the 50th anniversary year of the NCAC. BCA Executive Board approved a motion made by Ed Fendley to contribute \$20 for a party to celebrate the anniversary.
 - g. Civic Federation Dean Foster, David Hughes, Suzanne Sundburg, Carla Aly, Craig Deering, Mark Haynes. No report was given.
 - h. Sidewalk Safety Task Force Ed Fendley, Chris Healey County staff have indicated that Phase 1, consisting of a multi-modal study, and re-paving followed by re-striping will kick off soon. A special meeting of the Task Force has been called for Monday, July 28th at 8 P.M. at Fire Station No. 2 for a presentation by and discussion with County Staff.
 - i. Bluemont Neighborhood Village Center Task Force Carla Aly, Kate Mattos –Kate Mattos reported that the Task Force is regrouping and considering the way forward in the absence of any response from Safeway Corporation to BCA's repeated requests for an update on their announced plans to re-develop their property at 5101 Wilson Blvd.

- j. 25 Glebe Task Force Terry Serie reported that Penrose Group has submitted a site plan request for their project at 672 N Glebe. Rd.
- k. Parks and Recreation Liaison A Member asked Nora Palmatier to look into the problem of bushes and other plants in parks and other public lands encroaching sidewalks. Other members stated that a call to Arlington Count Code Enforcement usually results in a quick resolution of such problems.
- I. Ashlawn BLPC Lizabet Boroughs was absent. Craig Deering reported that the expanded Ashlawn School was on schedule to open on time at the start of the new school year. He stated that a meeting was to be held July 30th at 7 p.m. to discuss circulation issues (see item 6 a below).
- m. McKinley BLPC Larry Smith gave no report.
