#### **Taming Wilson Boulevard Traffic**

#### ATM Study Convened on Oct. 7

On Tuesday evening, October 7, representatives of Kimley-Horn and Associates (the transportation planning and engineering company selected by Arlington County for this project) and County employees met with community residents to discuss the Arterial Transportation Management (ATM) Study for Wilson Boulevard. The study covers the section of Wilson Boulevard between North George Mason Drive and the County line.

While many ideas were discussed, residents focused on speeding, pedestrian safety, and traffic management as areas of great concern. After breaking into small groups, residents proposed potential alternatives to address the traffic and safety problems. Some of the more popular suggestions included the widening of sidewalks, the installation of curb nubs adjacent to crosswalks, the undergrounding of utility lines, a reduction in the number of travel lanes, a reduction of speed, and the addition of bike lanes.

#### Wilson Walkthrough Scheduled for Nov. 8

The next ATM Study event will be a community walkthrough that will be held on Saturday, November 8 at 9:00 a.m. (everyone will gather along the sidewalk next to the Safeway parking lot). Members of the community will have an opportunity to walk with County employees and representatives of the consulting company to point out problem areas and discuss solutions. We urge all BCA members to attend this important meeting.

Once feedback from the walkthrough has been reviewed, the County/consultant will produce a draft plan that should be released for public comment sometime in December. The final plan should be unveiled in the spring of 2004.
