

JBG Presents Revised Peck/Staples Plan

JBG, the developer of the Peck/ Staples site (at the corner of Wilson and Glebe), will present its revised plan to the membership at the November meeting. Please note that this presentation is in addition to the first Site Plan Review Committee (SPRC) meeting **on December 14**—the public meeting at which residents will have an opportunity to directly express their opinions about the plan to the County. If there is sufficient public comment at the first SPRC meeting, then additional meetings will be scheduled to hear and address all residents' concerns. At presstime, the place of the December 14 SPRC meeting is still to be announced.

Due to the Thanksgiving holiday, Bluemont Civic Association's (BCA's) November general membership meeting has been moved to Wednesday, November 29, 7 pm, at Lubber Run Community Center, 200 N. Park Road (at the corner of George Mason and Park).

NC/Traffic-Calming Funding Crisis

Neighborhood Conservation Advisory Committee (NCAC) Representative Wendy Dean has been advised that due to chronic funding shortfalls for already-approved projects, the prospects for funding any <u>new</u> NC projects would be highly unlikely over the next 10 years. All approved NC projects in the Bluemont area are over budget (because they were funded at less than their projected cost) and are at least two years behind schedule. Bluemont's two toppriority projects (N. 9th Street and N. Frederick Street) in the existing queue have not yet been approved, and there likely will not be an opportunity to resubmit these projects for funding until sometime in 2008.

Similarly, the County's trafficcalming program has serious funding problems, and the County is proposing to cancel the program. All residents who support traffic-calming efforts should let the County Board know. \rightarrow **4**



BCA MEETINGS AT A GLANCE...

LAST GENERAL MEETING, OCTOBER

• Ferguson Visit—County Board member Paul Ferguson spoke on a number of topics. With respect to the Peck/Staples plan, he indicated that the Board had not specifically solicited a redevelopment proposal along the lines of JBG's proposal and said the Board would listen to input from BCA and its members. Ferguson insisted that the Board has made no commitments to JBG to approve the proposed rezoning ("upzoning or up-GLUPing") of the Peck/Staples site.

With respect to the NC funding crisis, Ferguson said that he would suggest moving curb, gutter, and sidewalk projects from the NC budget to the County's general maintenance budget in order to help relieve the NC bottleneck. In response to a member's concern about the lack of a left turn signal (from eastbound Wilson Blvd. onto northbound Glebe Rd.), Ferguson promised to solicit feedback from civic associations for a list of intersections where left-turn arrows are necessary.

• Wilson ATM Plan—Richard Best presented the 90% design plan for the Arterial Traffic Management (ATM) project along Wilson Boulevard (between George Mason Drive and N. Frederick Street). The design plan includes a landscaped median along parts of Wilson to create a pedestrian safety zone, landscaped strips in front of 7-11 and Safeway, bus shelters in front of Safeway and Federal Lock & Key, **→ 3**

• A county representative will present a proposed revision to the Arterial Transportation Management (ATM) landscaping plan for the intersection of George Mason Drive and Wilson Boulevard. The County mistakenly placed an electrical box on the sidewalk. Now the Parks Department wishes to redo the landscaping for this intersection.


widened sidewalks in front of Two Chefs and the BP station, the removal of street parking from the south side of Wilson in front of Federal Lock & Key, and cross-walks from Safeway to N. Emerson Street. Best anticipates that construction will begin in November 2006 (weather permitting).

The membership voted unanimously to approve the 90% design plan. BCA Executive Board members thanked Best for his progress and continued commitment to the project. (Special note: BCA also wishes to thank the local business and property owners that supported and/or granted easements so the sidewalks could be widened.)

•<u>New Peck/Staples Coordinator</u>—The membership voted unanimously to name BCA member Terry Serie as its Information Coordinator for the redevelopment project and authorized Serie to obtain information regarding the project and disseminate such information to the membership. As you may recall, Serie served as BCA's representative for the proposed Glebe 25/Silverwood development project (a 9-story condo building on Glebe Road near Carlin Springs Road). The developer has withdrawn that plan. ■

JBG's plan for 12-story and 8-story office buildings and 28 four-story townhouses greatly exceeds the current zoning and the General Land Use Plan (GLUP) limits that govern the Peck/ Staples site. JBG intends to ask the County to increase the zoning (enabling greater height and density) and to adjust the landuse plan as well. Many neighbors have expressed concerns about traffic, parking, height and other

problems. In fact, JBG's own traffic studies (which did <u>not</u> include a review of several nearby intersections, including N. Tazewell Street and Wilson Boulevard) project traffic failure at key intersections like Glebe and Wilson, both in the morning and evening rush hours. At this point, JBG has revealed no plans to minimize the traffic problem and its impact on nearby residents. **Get involved! Other Development News

•<u>Ballston Row</u>—Larry Wingard of HJL Properties is working on a plan to replace two apartment buildings with 16 townhouses at the corner of Fairfax Drive and Buchanan Street. A few BCA members met with Wingard in October to review preliminary drawings and to ask Wingard to preserve as many healthy, mature trees as possible. Wingard requested an opportunity to present his plan to the general BCA membership once he has a firmer timeline and a better idea of the plan's economic feasibility.

• The Fairmont (the old INS building on Fairfax Drive)—According to Paul Ferguson, JBG has suspended its plan to replace the old INS building with a 23-story, mixed-use condominium building. Originally, JBG had agreed to construct part of the new western entrance to the Ballston Metro station in return for the County Board's approval of significant additional density/height. JBG appears to have concluded that the project, as planned, is no longer economically feasible. ■
