# **They're Back** – JBG Rosenfeld to Discuss Safeway Plans

At this Wednesday's BCA General Meeting at Arlington Traditional School, Representatives from JBG Rosenfeld Retail (a partner of The JBG Companies, developer of the Peck-Staples site) will be on hand to discuss the redevelopment potential for the Safeway site (5100 block of Wilson Boulevard). As was discussed at BCA's September meeting, a representative of JBG contacted BCA President Judah dal Cais over the summer to chat informally about Safeway's request for proposals to redevelop the site. When dal Cais contacted the Arlington Office for Economic Development, however, a county staff member stated Safeway was not interested in selling or redeveloping the Wilson Boulevard site.

At present, there is no way to explain the discrepancy or to know which version of events is correct. Also noted at the September meeting, the County Board has not taken a public position on whether it would support the increased height and density that would likely accompany any mixed-use redevelopment of the Safeway site. (The current by-right height limit is three stories, which would likely allow for a townhouse development.) Interest parties are urged to attend the meeting on Wednesday.

# Arlington Forest Club Seeks Support for Expansion at September General meeting

Karen Serfis, representing Arlington Forest Club's board, presented the club's renovation plans for its bathhouse, built in 1959. #### LAST GENERAL MEETING 9/24 Arlington Forest Club Renovation Plan

The club is planning renovations to its nearly 50 year-old building. (See full story on page 1).

#### Bluemont Park Split-Rail Fence Removal

Kevin Stalica, a county parks manager who is in charge of trails, addressed the membership at the September meeting. He apologized for the unannounced removal of the split-rail fence adjacent to the bike trail in Bluemont Park on 8/2/08. When he made the decision to remove the fence (which was at the end of its "useful" life), he was unaware of neighbors' requests for the fence to be repaired, not replaced. (Several Bluemonters had made these requests during the June 2007 Walking Town Meeting.)

Stalica reported that the county had received letters both for and against removal of the fence (although he declined to say how many of each were received). The membership discussed several options for replacing the fence, including a suggestion to plant native bushes and trees in place of the fence. The county asked BCA to determine what option it would support: replacing the fence with another fence (style to be determined), replacing the fence with vegetation, or simply leaving the space open. BCA member Kate Mattos is spearheading the collection of comments from BCA members. Please forward any comments/suggestions to her at kmattos@comcast.net. This feedback will be discussed at the October 22 meeting, and the membership will vote at that time on which option it will recommend to the county.

#### **Replacement of Quincy Street Recycling Center**

At the September Executive Board meeting, a member noted that the N. Quincy Street recycling collection center would be closing to make way for a number of new office buildings. It was suggested that BCA offer a site within Bluemont to replace it. The board discussed the area near N. Kensington Street and N. Carlin Springs Drive (where the power transmission lines are located) as a possibility.

The membership discussed this site at the September general meeting, but one member objected to locating a recycling station there due to poor road visibility along Kensington and poor lighting in the area. A county staff member who attended the 9/24 meeting informed the membership that neither of the two replacement recycling sites being considered are in Bluemont. The county is considering either 19th and N. Kirkwood or Quincy Park as a possible replacement site for the recycling collection center.

# Arlington Forest Club

The club plans to renovate the bathrooms to make them compliant with American with Disabilities Act (ADA) requirements, and the locker room/changing areas also would be upgraded. Under the plans, a new second-story deck would allow spectators to view the pool area.

The club's membership roll will continue to be capped at 675 members, and the same maximum pool occupancy limit of 224 would continue to apply. The primary point of concern is parking. The club currently has 80 parking spaces (some in the paved lot and some in the grassy lot next to N. Carlin Springs Road). The county is asking the club to increase the number of parking spaces to 118. However, this would require the club to pave the grassy lot (and cut down many mature trees).

According to club surveys, each car parked at the facility contains an average of 3.2 people. At that rate, if all 80 parking spaces were filled, there would be 256 people onsite (which would exceed the pool's occupancy limit). It therefore would make little sense to provide additional parking spaces for people who could not be admitted to the pool. Even if the grassy lot were to be paved, the club still would not meet the county's 118-space requirement.

Several BCA members who live nearby the club spoke out against paving the grassy lot, citing the loss of trees and the resulting increase in rain runoff during storms due to the increase in impervious surface.

The club asked the membership for a letter in support of its renovation plan—keeping off-street parking capped at 80 spaces and leaving the grassy lot as is—to be sent to the county on October 22. A preliminary vote by BCA members was unanimous in support of the plan. The BCA membership will take a final vote on the Arlington Forest Club renovation plan at its 10/22/08 general membership meeting. To review plan details, please visit www.bluemontcivic.org.■
