LAST GENERAL MEETING 3/25

At the March meeting, Environmental Landscape Supervisor Patrick Wegeng discussed how the proposed cuts to the 2010 Parks Division budget will further restrict the types of flowers that Wegeng's landscaping team can plant in the Bicentennial Flower Garden (at the corner of Wilson and George Mason). Budget constraints also will limit the number of man-hours Wegeng's team can devote to maintenance of the Bon Air Rose Garden (see related article in the January '09 issue of *BCA Neighborhood News* available at www.bluemontcivic.org and the call for volunteers on p. 4).

Wegeng also briefly discussed the Whitman-Walker Clinic's meditative garden and walkway. (The Whitman-Walker Clinic on Lee Highway is being torn down to make way for new development.) An ad hoc committee is exploring how the garden may be donated and moved to county park property, and Bon Air Park is being considered as a new home for this contemplative garden. Due to budget constraints, however, Wegeng's staff is prohibited from removing, re-installing or caring for the garden. Therefore, one option being discussed is the formation of a nonprofit group that would fund both the transfer and ongoing maintenance of the garden. ■

Arlington County Board has approved a \$15,000 park enhancement grant (PEG) that BCA member Chris Healey wrote and submitted last year. The award will fund the construction of a 100-foot asphalt trail (dubbed the Revolutionary War Connector Trail in honor of a local hero) that will connect the abandoned portion of Old Fairfax Drive (at N. Harrison Street) to the Custis Trail.

• Bluemont Park fence replacement—BCA member Kate Mattos alerted the neighborhood when the county unexpectedly removed the split-rail fence next to the Bluemont Park trail last August. After several discussions with the county, the membership selected a new fence (which has been installed) and landscaping that should be installed later this spring. ■

What's the State of Your Street?

Perhaps your street has an incomplete sidewalk (or no sidewalk). Or perhaps your street is missing its curb and gutter. If so, consider forwarding your project to Carl Drummond, BCA's Neighborhood Conservation (NC) representative. The NC program is a bond-funded program that funds improvements like curbs, gutters, sidewalks and lights.

Several BCA projects have been constructed using NC funds, including N. Harrison St. between 10th St. North and Wilson Blvd. (traffic calming and sidewalks) and N. Kensington St. between 8th Rd. North and N. Carlin Springs Rd. (sidewalks, curb and gutter, traffic calming). BCA would be happy to help you acquire such improvements for your block. First, you'll need to identify a block captain who can oversee your project through the 3- to 6-year funding process. For more details, contact Carl Drummond at CarlD10@aol.com. ■

NC Plan Update and the Village Center Concept

In March, BCA voted to formally update its NC Plan. This fall BCA will distribute an in-depth questionnaire to all Bluemont households (approx. 2,000) as part of the NC Plan update process.

One NC-related issue of ongoing discussion is the potential redevelopment of the Safeway site. BCA's NC Plan update process may provide a means of reaching a consensus on what type of development Bluemonters would accept at that site. (Note: The plan will be subject to county approval, and the county will have input into the final plan.) The NC Plan update committee is working in conjunction with the Bluemont Village Center Working Group (formerly the Wilson Boulevard Revitalization Working Group) to determine whether Bluemonters would be in favor of a "village center" design concept to help guide future redevelopment of the Wilson Boulevard commercial area.

Members of the update committee and the working group recently met with Shelley Mastran, a Virginia Tech professor who teaches urban planning. It is hoped that Mastran's classes may be able to help BCA determine feasible options for the potential redevelopment of the commercial area. In order to garner initial feedback on the proposed village center concept, a brief preliminary survey appears below.
