# Lighting and Zoning and Codes, Oh My

### October General Meeting Crowded and Lively Once Again

Holiday Inn Lighting Presentation — A representative from the Holiday Inn's management team and several representatives from Walsh, Colucci, Lubeley, Emrich & Walsh, P.C. explained the light proposal for the N. Fairfax Drive hotel, which employs 150 people. These lights must be added by January 2010 in order to meet new companywide standards and the hotel's licensing agreement with Holiday Inn. New 70-watt and 150-watt green lights would be installed on the front of the hotel and on the east side, but not on the south side facing nearby residences. The county classifies these lights as additional signage, which therefore requires a site plan amendment. The site plan amendment will be presented at the County Board's November meeting. County staff is recommending denial of the application. The membership made and passed the following motion: "Based on the presentation this evening BCA supports the site plan amendment."

Arlington County Police — Two officers substituted in for BCA's community liaison Officer O'Daniel. The officers reported no major crimes in Bluemont recently. Officers are patrolling on bicycles every other week to discourage vandalism by school kids along the bike paths. Neighbors are asked to call the non-emergency police phone number to report graffiti or late night party noise. In answer to a noise-related question (discussed at the September meeting), the officers noted that there would be a new program making it possible for code enforcement staff to monitor excessive noise at com-

# Ready. Rake. Recycle.

The county's 2009-2010 bagged leaf collection program started on 11/2/09 and runs through 1/15/10. To recycle your leaves, place leaves in brown paper biodegradable bags only. Do not use plastic bags! Leaf bags will be collected on the next business day after your regular trash collection day through 1/15, including holidays, except Christmas and New Year's Day. (If your trash is collected on Fridays, your last leaf bag collection will be on 1/11/10, with no collection on 1/18/10. Visit www.arlingtonva.us/des to find the locations where you can pick up free bags through 1/9/10 (while supplies last). The Web page also provides detailed leaf collection information and quidelines.

Vacuum leaf collection runs from 11/13/09 through 12/24/09. Crews will make two complete passes through each neighborhood. Signs will be posted two to three days before trucks arrive. mercial establishments at night and on weekends using a soundmeasuring device.

**Zoning Office Presentation** — Zoning Administrator Melinda Artman and County Planner Melanie Jesick explained the Board of Zoning Appeals (BZA) and County Board use permits and variance process. Artman and Jesick answered a number of questions about the consistency of enforcement, encroachment, and the limitations of the zoning office. Artman also noted that just three accessory dwelling units — all located in new homes — have been added to the county's housing stock this year. **D&V Auto Service Center Motions from 9/30/09** — The membership discussed and then passed the following two motions: 1) BCA supports the mechanical automobile repair services being performed at the D&V Auto Service Center located at 5201 Wilson Boulevard. 2) BCA supports negotiations between D&V Auto Service Center (located at 5201 Wilson Boulevard) and nearby residents to determine a list of conditions that D&V would have to meet in order for BCA and residents to support the continued operation of the rental truck business.

Robbie Guenther, who owns D&V, will appeal Zoning Administrator Melinda Artman's decision to prohibit automotive repairs and the truck rental business. The matter will be heard and considered by the Board of Zoning Appeals (BZA) on December 8. Paul Ducharme, a resident of the Carlisle Park townhouse development that abuts the D&V site, volunteered to contact nearby neighbors and set up a committee that will negotiate with Guenther to develop a list of conditions under which the community would accept the rental truck business to continue operating. The committee will forward these conditions to the membership at the 11/18/09 meeting for discussion and a vote.
