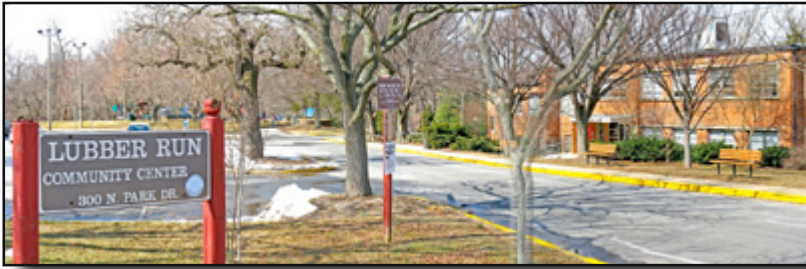

BCA Meetings at a Glance

March Meeting Highlights



• Lubber Run Community Center

Esther Bowring from Arlington Forest Citizens Association (AFCA) presented the county's proposals to replace Lubber Run Community Center either with an 800- to 1,200-seat middle school (which would involve closing N. Park Drive at George Mason Drive and cutting at least 175 mature trees) or with a committed-affordable-unit apartment building and new community center similar to the Arlington Mill project (6 stories with 122 apts. and 322 parking spaces).

The Arlington Forest community objects to both plans, as they would destroy or degrade increasingly scarce natural parkland, eliminate facilities currently used by Barrett Elementary School and an existing preschool program, and increase the strain on local roads and other infrastructure that are already overburdened by the addition of 500 recently built apartments and 90 townhouses in the neighborhood.

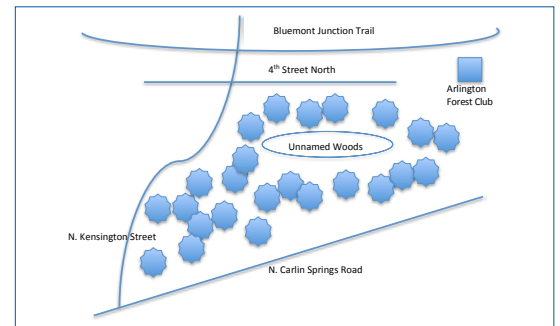
In response to Bowring's presentation, the membership voted to advertise the following draft motion:

"The Bluemont Civic Association supports the preservation of increasingly scarce open space and green space in Arlington County. In this same spirit, the BCA also supports the highly used and versatile Lubber Run Community Center. Therefore, the BCA supports the resolution of the Arlington Forest Citizens Association of March 19, 2014."

• Proposal To Name Woodland

Last year, a BCA member fell and broke a hip while walking in a wooded area in the Bluemont neighborhood bounded by N. Carlin Springs Road, N. Kensington Street, N. 4th Street, the Bluemont Junction Trail, and the Arlington Forest Club. Because this area is wooded and without any location signs, it took nearly half an hour and repeated calls to 911 for rescue personnel to reach the victim.



Naming this woodland is seen as an important step toward remedying a safety problem as well as giving the area a sense of place. After extensive research, BCA member Steve Cole discovered that these woods were owned for almost a century by historic figure Mary A. Carlin, who was born in the nearby log house that bears her name on N. Carlin Springs Road.

In response to the discussion of this matter, BCA members voted to advertise the following draft motion: "The Bluemont Civic Association recommends to the Arlington County Board that it name the woods bounded by N. Carlin Springs Rd., N. Kensington St., N. 4th St., the Bluemont Junction Trail, and the Arlington Forest Club, the Mary Carlin Woods." BCA members will discuss and vote on this motion at the April 23 meeting.

School Board Vice-Chair Sally Baird (who leaves the board on Dec. 31) is the BCA's new liaison to strengthen Arlington Public Schools' (APS's) relationship with the Bluemont community. Ms. Baird will be our guest speaker at the May 28 meeting. (If enough BCA members express interest, she also has offered to meet with us in person or online prior to the May 28 meeting.)

On the minds of many is whether parts of Bluemont may be moved from Washington-Lee High School into the Wakefield High School attendance zone. APS is scrambling to deal with overenrollment at many Arlington schools, including Washington-Lee.

Shop Small: Support Local Small Businesses

The Small Business Majority, a national small-business organization, recently surveyed small businesses. Of those surveyed in Virginia, 87% reported financial hardship resulting from the winter weather. The impacts included employee layoffs for one in five businesses.

Bluemont has a vibrant small-business community: over 12 restaurants (some Zagat rated) at different price points serving cuisines from around the world, a barber shop, a nail salon, an antiquarian bookseller, two drycleaners (one with a laundromat, the other offering shoe repair and tailoring services), two service stations providing repairs and gas, a lock and safe company, a physical therapy/rehab center, a watch and clock repair shop, two pharmacies, two unique boutiques selling collectible home furnishings and jewelry, and much more!

Shopping local pumps dollars back into our local economy and helps provide jobs. Moreover, at least three of Bluemont's small business owners also live in the neighborhood and have made a significant investment in our community. So the next time you shop, stay local and shop at your nearby small business.

Soil Testing

Get ready for growing season! Virginia Cooperative Extension offers routine soil testing to provide a fertility evaluation. Soil samples are analyzed, and computer recommendations are generated usually within three working days of receipt.

Pick up a soil sampling box at the Virginia Cooperative Extension's Arlington office (3308 S. Stafford Street). Send your filled soil-sample box with a completed form and the fee to the Virginia Tech Lab (the address is on the box) for analysis.

Wilson Boulevard Sidewalk Safety

County Board member Mary Hynes will accompany BCA officers and members of the Sidewalk Safety Task Force on a May 1 Metrobus tour of Washington Boulevard's two-lane configuration with pedestrian-friendly features and intermittent bike lanes west of George Mason Drive.

Washington Boulevard carries approximately the same traffic volume as Wilson Boulevard.

County staff indicates it will start a Multimodal Transportation Study for Wilson Boulevard from Glebe Road to the Fairfax County line.

The BCA asked the county to improve Wilson Boulevard sidewalks and proposed restriping the roadway west of George Mason Drive to create a new two-way center turn lane, dedicated turn lanes at intersections, periodic safety islands, one through-lane in each direction, and new bicycle lanes.

The ultimate goal is to widen sidewalks and improve safety for all roadway users while maintaining the safe flow of traffic. The Dominion Hills Civic Association has expressed support for the BCA proposal.

Redevelopment Recaps



Marymount — 1000 N. Glebe Road

- **Marymount/Blue Goose Site**—In Jan., the County Board approved a 9-story office building and a 15-story, 267-unit apartment building with 582 underground parking spaces to replace the Blue Goose building at 1000 N. Glebe Road. In return for the substantial increase in density, the developer/Marymount will contribute \$5.718 million in community benefit funds that are earmarked for improvements to the Ballston Beaver Pond, the Custis Trail, and a west entrance for the Ballston-MU Metro Station.
- **The Springs Apartments/APAH**—In Jan., the County Board approved a 5-story, 104-unit apartment building with 110 parking spaces at 4318 N. Carlin Springs Road. Owned by Arlington Partnership for Affordable Housing (APAH), the new building will contain 98 committed affordable units (CAFs) to replace the existing 27 CAFs.



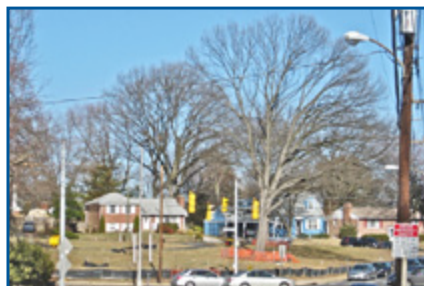
25 Glebe — 600 N. Glebe Road

- **25 Glebe/Penrose**—In Feb., BCA members passed a resolution offering conditional support of The Penrose Group's proposal to build a 6-story, +/-180-unit apartment building with ground-floor retail in the 600 block of N. Glebe Road (the Exxon station and Macy's parking lot parcels). The developer indicated it would submit final plans to the county in March.

- **Bluemont's Safeway Site**—According to the BCA's Safeway/Bluemont Village Center Task Force, Safeway temporarily "paused" its process on Bluemont's Safeway due to a "management change." In mid-January, the Task Force received a call indicating that Safeway would have more redevelopment news by early April and that it plans to move forward on the redevelopment of the site with a new store. Lacey Lane project to restart

- **Lacey Lane**—Construction of Lacey Lane (at Washington Blvd. and N. George Mason Drive) halted several months ago. Real estate records indicate the parcel changed hands in December 2013 for \$5,700,000. According to neighboring Waycroft-Woodlawn Civic Association, Evergreene Homes intends to resume construction soon. The plans include nine detached homes with four finished levels, detached garages, and landscaped courtyards. In addition, Arlington's Real Estate Tax Relief Program provides an exemption and/or deferral of real estate taxes for qualified Arlington homeowners age 65 and older and for certain totally and permanently disabled homeowners.
