BCA Meetings at a Glance

Meeting Recaps

October

At the 10/28 meeting, members passed a motion to vote at the Nov. meeting, authorizing the BCA president to send a letter to the Arlington County Board expressing concern that the proposed High Occupancy Toll (HOT) lanes may increase traffic along arterial, local, and connector roads in the Bluemont neighborhood and throughout Arlington. However, the matter came before the County Board prior to the BCA's Nov. meeting, and with the Executive Board's consent, the president sent a letter about the HOT lanes to the County Board on 11/18.

The members also passed a motion authorizing the BCA president to send a letter to the County Board about the Ballston Common Mall redevelopment project to remind Board members that Bluemont's Neighborhood Conservation Plan supports a western entrance to the Ballston Metro and to ask that community benefit funds be used for this purpose. Pres. Rovder subsequently sent this letter to the County Board on 11/16.

Copies of both letters were distributed at the 11/19 general meeting and will be attached to those minutes.

November

Due to an ATS scheduling conflict, the BCA's meetings moved from 11/18 to 11/19.

Reeves Farm Conservation Society Representative Sandra Spear spoke about the group's proposal to buy and historically preserve the Reeves farmhouse and outbuildings. Although the website is still under construction, photos of the property can be seen at <http://reevesfarmconservation.com>.

Members also voted to advertise the draft motion below, which concerns the proposed new requirements for civic associations putting forth Neighborhood Conservation (NC) projects for county funding:

The Bluemont Civic Association (BCA) declines to support the proposed changes to the Neighborhood Conservation Advisory Committee (NCAC) as currently drafted in its May 18, 2015, document, "Proposed Plan for Neighborhood Conservation Advisory Committee (NCAC) Neighborhood Enhancement Planning Process," and in the

companion "Comparison of NCAC approval of neighborhood plans vs. proposed plan for project approval."

With more than 2,000 households within its boundaries, the BCA has inadequate volunteer manpower, financial resources and organizational structure to carry out the notification efforts required by these proposed changes. The BCA has successfully utilized the existing "clipboard" method to poll immediate neighbors of proposed projects to discern whether there is sufficient primary stakeholder support (60% or greater) for a project before adding it to the funding queue.

Putting forth projects that do not have strong primary stakeholder support invites conflict and runs counter to the BCA's historical practice of giving special consideration to the views of primary stakeholders and those living closest to a proposed project in deciding whether or not to support the project.

The membership instructs the BCA president to send a letter to NCAC stating the BCA's objections noted above.

The BCA's NCAC Representative, Rich Gibson, reported that other civic associations had expressed objections to these changes at the last NCAC meeting. Concerns include the elimination of the current polling of stakeholders (residents/property owners living on the same block or near a proposed NC project) to confirm that that 60% of those living nearest a project would support it. Typically, the BCA

has recruited its NC reps from among block captains who want to implement an NC project on their own blocks.

The new rules formalize the procedures for notification requirements, making civic associations completely responsible for notifying ALL property owners (including absentee owners) within the civic association's boundaries before voting to approve an NC project.

Within the BCA are more than 2,000 households, making notification efforts very labor intensive and expensive. Because notification would formally become civic associations' responsibility, there is also an extension of legal liability from the county, whose employees are indemnified against lawsuits, to unincorporated and/or un- or under-insured civic associations and their volunteer-members.

The new rules also require civic associations to permit absentee voting and the ability of nonmembers to vote, which run counter to many civic associations' bylaws, including the BCA's.

Unfortunately, the NCAC has not made its documents outlining these changes available online. However, copies will be attached to the 11/19 general meeting minutes for review. Members will vote on the motion at the upcoming 12/16 BCA meeting.

New Bikeshare Stations Coming



In line with BCA input, Arlington County is planning to install new Capital Bikeshare stations at Washington Boulevard and N. Frederick Street and at Wilson Boulevard and N. Illinois Street. Work on the concrete pad for the station at Washington Boulevard and N. Frederick Street has already begun.

These plans respond to requests from Bluemont residents. The BCA set up the Task Force on Adding Capital Bikeshare Stations, which identified the two noted locations. They were among several sites that the Task Force determined to be preferable. On behalf of the BCA, Co-chairs Ed Fendley and Nick Babiak thank all who participated in the Bikeshare planning process for their hard work and interest.

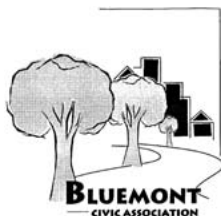
