## Police Liaison Invited

Please join us on Wed., 3/30, at Arlington Traditional School (ATS), 855 N. Edison Street. The Executive Board and general membership meetings will begin at 7 and 7:30 pm, respectively.

In response to concerns about loitering expressed by members at the February meeting, the membership voted to invite the BCA's police liaison Cesar Ruiz to the March meeting to discuss the issue as well as any other public safety matters in our community.

Members will vote to elect Nominating Committee members (see p. 4). BCA committee reps and liaisons will update members on redevelopment projects, expanded commercial loading dock hours (being appealed by some Bluemont residents, see p. 2), and the new designs for Lubber Run Community Center. Come ask questions and raise other items for discussion.

## Mazda Site Redevelopment Update

The third site plan review committee (SPRC) was held on March 7. Transportation in and around the site—located on the southwest corner of the Wilson Blvd.–Glebe Road intersection—was discussed.

Of the 9 alternatives proposed by the applicant for access to and circulation within the 483-unit building, only 3 (including the original proposal) were acceptable to VDOT—according to staff. No decision has yet been made with respect to which alternative will be selected. There appeared to be fairly strong support for a residential and retail entry drive on N. Glebe Road to take some of the traffic load off of 7th Street North and N. Tazewell Street, which are residential streets.

The committee chair took an informal poll of SPRC members showing little or no enthusiasm for changing a portion of North Tazewell Street into a two-way street.

The next SPRC meeting will take place on March 21. At that meeting or perhaps a fifth meeting, the SPRC will discuss site plan conditions, including a requirement for a grocery store on the ground floor and for the loading dock (on 7th Street) hours to remain restricted during the late evening/early morning hours and on weekends.

It is thought that the County Board may consider this plan as early as its April 16 meeting.

## Loading Dock Hours Expansion

In February, BCA members discussed the Va. Tech loading dock (site plan #401). Va. Tech (900 N. Glebe Road) sought an administrative change to existing site plan conditions back in November, asking to increase the buildings' loading dock hours from 9 am–4 pm/6 pm–8 pm M-F and 9 am–6 pm weekends/holidays to **5 am–11 pm, 7 days a week.**

The Zoning Administrator approved the change in December. However, the BCA was not notified of the proposed change, nor was community feedback solicited prior to the decision. The BCA learned of the matter after a representative of the Ballston Park HOA reported that the HOA was appealing the Zoning Administrator's decision before the Board of Zoning Appeals (BZA).

Site plan conditions the Arlington County Board approved in 2008 controlled the original loading dock hours. These hours took into account the presence of **townhouses built approximately 50 feet from Va. Tech's loading dock** and service drive as part of the site's redevelopment.

The newly expanded hours (5 am–11 pm daily) appear to conflict with the "prohibited acts" listed in the county's noise control ordinance § 15-6.H., which states:

"It shall be unlawful for any person to collect refuse with a refuse vehicle during the Nighttime," where "nighttime" is defined 9:01 pm–6:59 am on weekdays and 9:01 pm–9:59 am on Saturdays, Sundays and legal holidays.

Even though the County Board approved the updated noise ordinance in May 2014, it has not asked the Zoning Administrator to rescind her determination approving the conflicting loading dock hours for this case.

Not only is this change problematic for the residents of these townhouses, it also sets a terrible precedent for all commercial loading docks that are built near residential neighborhoods. Sites also potentially affected included the recently approved 672 Flats, the upcoming Mazda site and, potentially, any future redevelopment along Wilson Blvd. in the heart of Bluemont.

The BZA will hear the Ballston Park HOA's appeal on April 13, 7 pm, in the County Board room, #307, at 2100 Clarendon Blvd. The public can send letters supporting the appeal (and opposing the loading dock hours expansion) to the BZA's staff coordinator, Andrew Noxon, at [Anoxon@arlingtonva.us](mailto:Anoxon@arlingtonva.us). # BCA Meetings at a Glance

## February Meeting Recap

[Note: January's BCA meeting was canceled due to snow.] BCA members heard an update on the Lubber Run Community Center. Once the school system decides whether it will use the facility for a new preschool (replacing the existing co-op preschool), then the county may come back with revised designs to address the community's request for a smaller footprint and less loss of green space and existing trees.

The membership discussed the county's disappointing snow removal efforts and voted to authorize the BCA president to draft and send a letter to the County Board highlighting the problems with snow removal in Bluemont and asking for modifications to the county's existing "phase" system for clearing snow.

The membership also voted to authorize the president to draft and send a letter to the Board of Zoning Appeals (BZA), opposing the expansion of late evening/early morning and weekend hours for the Virginia Tech building (900 N. Glebe Road). See p. 2 for more details.
