Safeway Site Committee Launched

Bluemont residents interested in the future of our neighborhood grocery store are encouraged to join the Safeway Site Committee as a volunteer. During the Sept. 28, 2016 BCA General Membership meeting, the BCA President was authorized by vote of the General Membership to establish the Safeway Site Committee (the final name of this committee is pending) to continue our consideration of the potential renovation or redevelopment of the property. This committee will follow a resolution adopted last spring which authorized the President to sign and send a letter to Safeway intended to re-establish a dialogue between the Bluemont community and Safeway.

While there are no active proposals for the site, there is continuing interest in developing a new grocery store with new housing. The committee is expected to review existing BCA positions, gather facts, and, if warranted, make recommendations to the BCA membership.

Redevelopment Projects

Update on 672 Flats (formerly the “Exxon Block” on 670 N. Glebe Rd.)



672 Flats at 670 Glebe Road, formerly the “Exxon Block”

As stated on the Arlington County Website, “The Penrose Group... is developing a six-story residential building containing 178 apartment units, approx. 4,500 square feet of retail, and 178 parking spaces in a two-level below-grade garage.”

Most recently, the site has been secured with a fence, and piles have been driven into the ground. Excavation has begun and you will see the “hole” from the street. The developer plans to complete excavation by the end of 2016 and to commence concrete operations in January 2017. Concrete should finish, and the framing should start by summer 2017. The developer’s planned completion date is June 2018.



750 N. Glebe Rd., formerly the “Mazda Block”

Update on 750 N. Glebe Rd. (formerly the “Mazda Block”)

According to the Arlington County Website, Saul Centers, Inc. has applied to “...rezone the property to RA4.8 and to redevelop the Rosenthal Mazda dealership and adjacent parcels with a 12-story building consisting of 483 dwelling units and 68,185 square feet of retail including a new grocery store and a car rental business.”

All tenants have departed and the property has been fenced. The contractor is in the process of disconnecting utilities to the buildings in preparation for demolition. Prior to obtaining a demolition permit, the contractor is required to have a meeting with the community to provide more details about the construction schedule, staging, truck hauling routes, and the like. The contractor will communicate with the community once it is prepared to set up that meeting.

The contractor is still in the Design Development stage of the building and hopes to move into the Construction Documentation phase by November/December of this year. Once the plans and specifications are complete, Saul Centers, Inc. will be bidding and awarding the job while awaiting the required permits to start construction. Excavation will not likely start until the middle of 2017 if all goes according to schedule.

Wilson Boulevard Crosswalk Improvements

In response to neighborhood requests, Arlington's Transportation Department is considering additional near-term safety improvements as well as planning for longer-term improvements on Wilson Boulevard in the Bluemont neighborhood. County staff is exploring options for raised medians and crosswalk improvements at selected locations between N. Frederick St. and N. Lexington St. In addition, the County may commission a study of options for future capital improvements to Wilson Blvd.'s sidewalks and the roadway between Glebe Road and the Fairfax County line. According to County staff, Arlington's Neighborhood Conservation Program could potentially fund both the crosswalk improvements and the study of longer-term investments in Bluemont's "Main Street." FAQs about Voting November 8, 2016

Election Day this year is Tues., Nov. 8. The polls will be open that day from 6 am–7 pm.

Unsure about your polling place?

That's not surprising, considering that the Bluemont Civic Association covers four different voting precincts: Ballston, Arlington Forest, Ashlawn and Westover. Just visit the Virginia Department of Election's website for a search feature that allows you to enter your home address and find your polling place at <https://voterinfo.sbe.virginia.gov/PublicSite/Public/FT2/PublicPollingPlace.aspx>.

Think you'll be out of town on Election Day?

You can obtain a Virginia Absentee Ballot Application Form by going to the Arlington County voter registration website and applying online at <https://vote.arlingtonva.us/absentee/>. Your application must be received by the Office of Voter Registration by no later than 5 p.m., Nov. 1.

Interested in voting absentee in-person?

Voters can go to the following locations to vote their absentee ballots in person—there's no need to obtain an absentee ballot in advance. Just show up on the open days and times to vote at the following locations:

Motions Passed!

It has been a busy summer! Here is a recap of the motions passed which summarize a few of the major movements within Bluemont.

- Motion passed by vote of Officers to authorize the President to sign and send a letter asking the County to postpone any fencing activity in the Bluemont Park field #3 until after a thorough public comment process has been implemented.
- Motion passed by vote of Officers to authorize the President to create a Bluemont Civic Association account on Nextdoor.com to use for official association announcements.
- Motion passed by vote of Officers to authorize the President to sign and send a letter requesting that the County postpone any decision on designating homes within Bluemont as 'historic' until after a thorough public comment process has been implemented.
- Motion passed by vote of Officers to sign and send a letter requesting that the County limit construction hours on the 1000 block of N. Glebe Rd. to 9 p.m. in response to the Site Plan #64 Amendment.
- Motion passed by vote of Officers and the General Membership to make sidewalk, curb, and gutter improvements to the 1000 block of N. Edison St. the second priority project for the Bluemont Civic Association's Neighborhood Conservation efforts.
- Motion passed by vote of Officers and the General Membership to ask the county to undertake a traffic study on 6th St. N (from N. Emerson St. to N. George Mason Dr.) and on N. Edison St. (from the Bluemont Junction Trail to N. Carlin Springs Dr.).

Leaf Collection

Arlington collects about 50,000 cubic yards of leaves every year, which are recycled into leaf mulch. The leaf mulch is then available for free pick up or can be ordered on line and delivered for a fee to County residents.

Biodegradable Bag Collection

- Oct. 31, 2016–Jan. 6, 2017 (Mon.–Fri. including holidays, except Christmas and New Year's Day)
- Leaf bags will be collected on your regular trash collection day.

Biodegradable paper leaf bags are available at most hardware stores. Free bags are available starting Oct. 24 and while supplies last at several locations listed on the County website. Do not use plastic bags.

Vacuum Collection

There will be two passes per civic association. Bluemont is in Zone 3. Our first Vacuum Pass is Nov. 11–16. The second is scheduled for December.
