## Safeway Site Committee's Final Report—April 26

Bluemont residents feel fortunate to have a grocery store in the neighborhood. The Safeway at 5101 Wilson Boulevard has served us for more than 5 decades. In recent years, there have been proposals to improve the Safeway, most recently in 2013 when a proposal was made to change current zoning to allow a 58,000 sq ft, 60-foot-tall building with at least 4 floors of apartments above a new store. After due consideration following a series of public meetings, BCA members voted to support a new store that would be built within current zoning standards, without the additional height and density that would be created by the construction of several floors of apartments above.

Nearby, Safeway has modernized stores on Lee Highway in Cherrydale and on Route 50 in the Willston Plaza across from Home Depot without

adding residential units above. Similarly, Safeway has demolished old stores and built brand new ones on Wisconsin Avenue in Georgetown and on King Street in Alexandria, again without the addition of apartments above. Further afield, Safeway demolished and replaced its store on Bradley Blvd. in Bethesda without adding apartments. One example of a redeveloped Safeway with residential units above can be found on Georgia Avenue in the District. The replacement Petworth Safeway, pictured below, was built a few years ago by developer Duball LLC.



BCA members voted last year to form a special committee to consider the possibility for change on the Safeway site. The committee met several times during the past few months and heard from planners, architects, transportation experts, and others to get professional views on the process, pros, and cons of redevelopment.

The committee is scheduled to make a report to the membership at the April BCA meeting.

## Carlin Springs Bridge To Be Replaced

Arlington County staff attended the BCA's Feb. meeting to present the County's upcoming plans to replace the bridge on N. Carlin Springs Road that crosses N. George Mason Drive. Under the plan, the current bridge would be completely replaced by a new bridge with four vehicular travel lanes, two bike lanes and wider sidewalks. The project will also entail the installation of a new sanitary sewer line under N. Abingdon Street and Carlin Springs Road. The County expects to award the project's contract this summer, and construction is slated to begin by the fall. Current plans are for the bridge's construction to be completed by the winter of 2018–19, with landscape restoration to be completed by the summer of 2019.

The Carlin Springs bridge will be replaced in stages, with the southern span being removed and replaced first. In order to ensure that traffic can continue to flow over the bridge throughout the project, vehicles will be able to use the span not under construction, with one travel lane available in each direction. Arlington County staff estimates that there will be two 5-day periods during which no traffic will be permitted on either N. Carlin Springs Road or N. George Mason Drive. During those periods, traffic will be re-directed via County-installed detours.

County staff represented that it will hold a community preconstruction meeting in late summer/early fall to provide more details about the construction plans. To learn more, visit <https://projects.arlingtonva.us/projects/carlin-springs-road-bridge/>.

## Bluemont Playground Restrooms Closed Nov.–March

Thousands of kids and parents from all over the County visit the Bluemont Park playground, known to most as the "train" park, year-round and in all weather conditions to enjoy the swings, bells, and general gravity of a train-themed park.

Even though this park is heavily utilized by people of all ages at all times of the year, Arlington County closes the restroom facilities from Nov. 15 to March 15 to save money. The amount of savings is less than \$4,000 annually. Playground users, including those still being potty-trained, are expected to walk a half-mile to a restroom at the park ranger's station. This is a 10-minute walk for an adult, on average. It is a much longer walk if you are between the ages of 1 and 8 years old.

This cost savings is in stark contrast to the more than \$718,000 spent on the new baseball "diamond" field just a couple hundred yards away. If hundreds of thousands of dollars can be spent to develop a diamond-level ball field with its own facilities, shouldn't the County also consider making the playground bathroom available to the entire community year-round for less than \$4,000?

In March, BCA members voted to authorize the president to sign and send a letter to DPR, the County Manager and the County Board, asking them to make lavatory facilities available to park users year-round at its affected 19 parks.

## The New Lubber Run Community Center

On Feb. 8, some 200 people of all ages and interests shared their ideas and suggestions for the project. Participants included local Boy Scouts, seniors, parents, singles, school-age children and teens. For those unable to attend this first session, an online survey was also made available to submit input.

The County's architect for the project, VMDO, Inc., was also the designer of the new APS Discovery Elementary School, which opened in 2015. VMDO used the input and suggestions from the session and the survey to present four "big idea" design schemes at public meetings in late March. The four scheme names — compact, portal, embedded and woven — represent each scheme's relationship to the park. For example, "compact" denotes a compact, 4-story design with the smallest footprint. "Woven" signifies a 1-story design similar to the Walter Reed Community Center.

One overall design scheme will be selected and then presented on May 17, (the selected scheme could be a synthesis of the four schemes listed above). In June, there will be a discussion as to how (and for what purposes) space will be allocated within the building.

A final design will be presented to the County Board and the community sometime this summer. If approved by the Board, construction would begin in early 2018, with completion in 2020 or 2021. The new center's maximum height will be four stories. The building will include a gymnasium and an outdoor playground. Underground parking will be utilized to maximize green space. The building must meet Leadership in Energy and Environmental Design (LEED) silver certification requirements and will incorporate solar energy features.

The County Dept. of Parks & Recreation's (DPR's) senior program at Culpeper Gardens will be relocated to the new center, and the center's existing preschool program will return once construction is complete. DPR's Sports and Recreation staff, who are now split between offices at Lubber Run and South Four Mile Run, will be consolidated in the new center.

The County Board has directed that the staff office space located in the center will be designed to complement, in form and function, the overall facility design as a community center. Other features of the facility will include outdoor multipurpose athletic courts, exercise/fitness rooms, and multipurpose flexible-use spaces for community, social and club meetings; teen activity space; and public computer use. The building's design is to be integrated into

the park, will protect and preserve green space, and will improve site access and safety. At press time, traffic studies and a tree inventory to plan for tree canopy preservation were underway. Geotechnical survey work will be performed to better assess the site's subsurface and surface drainage conditions.

## Motions Passed!

Below is a recap of the motions BCA members have passed since October.

- October 26, 2016, a motion was passed by a vote of the officers and members to authorize the BCA President to charter a Safeway Site Committee to consider the possibility for change on the Safeway site.
- November 15, 2016, a motion was passed by a vote of the officers and members to authorize the BCA President to contact the Arlington Forest Citizens Association President to ask whether the AFCA would want the BCA's support in the AFCA's position on school boundaries.
- February 22, 2017, a motion was passed by a vote of the officers and members to authorize the BCA President — with the participation of one or more members of the BCA Executive Board — to establish and maintain contact with Safeway Corporation's senior management to convey the BCA's official position concerning the potential improvement of the Bluemont Safeway store and to learn Safeway's future plans for the store. The BCA's official position is contained in the Bluemont Neighborhood Conservation Plan and in a resolution passed in April 2013. This authorization to communicate with Safeway senior management began March 17 and ends with the BCA Annual Meeting on June 27, 2017.
- March 22, 2017, a motion was passed by a vote of officers and members to authorize the BCA President to sign and send a letter to DPR, the County Manager and the County Board, asking them to make lavatory facilities available to park users year-round at the 19 parks where lavatory facilities are closed, Nov. 15–March 15, as a cost-saving measure.
