### MOTION: Support for Restoration of Mary Carlin Woods, Lacey Woods and Bon Air Park

"BCA supports the County's restoration efforts in Mary Carlin Woods, Lacey Woods and Bon Air Park, including from damage by unauthorized bike trail construction, bike riding, the July 2019 flooding and other issues, and calls for BCA to be fully included from the start in the County's restoration planning and implementation, and throughout the process of this restoration."

### MOTION: Including Bon Air Park in the CIP

"BCA should work to get Bon Air Park included in the next regular Capital Improvement Plan (CIP)."

## Why Bikes Are Prohibited on Natural Trails



Heavy use of trails, erosion, and direct impacts to roots can severely impact the trees and other natural resources in our parks. Damage to roots often creates pathways to infection, which show themselves years after the damage is done. Foot pressure and walking traffic rarely cause the amount of damage to kill trees, but grinding wheels from mountain biking have caused major decline in trees. These trees then change from having a high value to our community to becoming a risk to all trail users. Removal and maintenance of trees in heavily wooded areas is very costly, and deferring this work can lead to increased risk to all users and the park itself. November may seem far away, but it's time to register to vote or request an absentee ballot. If you are concerned about going to the polls this year, you can vote by mail—no excuse needed. The deadline to request an absentee ballot is October 23. Don't wait!

## Remaining Motions and Votes Since Our October 2019 Newsletter

**December General Membership meeting:** (1) Members voted to approve the Executive Board's decision to revive the BCA Pedestrian Safety Committee. Chris George and Nick Pastore volunteered to co-chair the Committee. (2) Members voted to advertise a vote at the January General Membership meeting to prioritize one Neighborhood Conservation project that the civic association will submit to the Neighborhood Conservation Advisory Committee, and one that will be the civic association's back-up Neighborhood Conservation project. (3) Members voted to advertise a vote to amend the civic association bylaws to reduce the requirement for a quorum for General Membership meetings.

**January General Membership meeting:** (1) Members voted to select the "Crosswalk and pedestrian safety improvements and beautification at the intersection of 6th St N, N Emerson, and N Edison the first priority Neighborhood Conservation project." The project will also address pedestrian safety concerns at this intersection. (**UPDATE:** Arlington County has completed road surveys at these intersections, and are designing possible safety concepts to present to Bluemont for comment in the coming months.) (2) Members selected "Crosswalk and pedestrian safety improvements at the intersection of N Lexington and Wilson Blvd in cooperation with the County's planned 8th Rd N and N Lexington sidewalk work" as the backup Neighborhood Conservation priority project. (3) Members voted to amend the bylaws to reduce the quorum requirement.

**June General Membership meeting:** Given cancellation of General Membership meetings due to public health restrictions, members voted to ratify the Executive Board's actions to follow bylaw requirements for transparent nomination procedures for annual elections, including extending the current Board until successors are approved in October 2020.
